Growth Model Portfolio

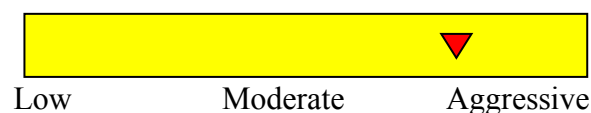
Portfolio Investment Objective

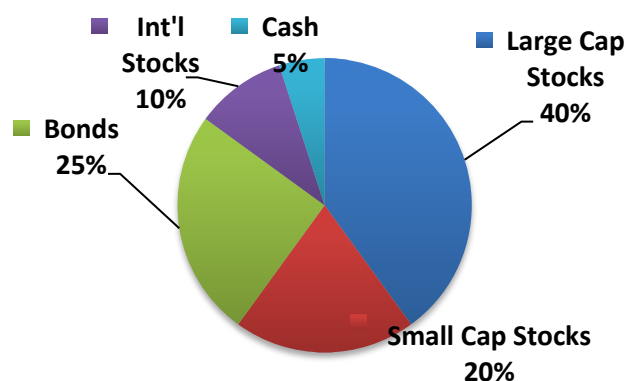
Risk Profile
